Discussion:

14. Discussion/Approval of proposed changes to the Bachelor's and Master's programmes at the Institute for European Studies of the Faculty of Law.

The Director of the Institute for European Studies of TSU and the author of the doctoral programme, Ms. Nino Lapiashvili, noted that certain changes have been made to the Bachelor's and Master's programmes at the Institute for European Studies, which can be categorized into three groups.

Firstly, the changes concern the list of program supervisors, as one of the co-supervisor, Professor Vasil Kacharava passed away. This event led to the adjustment of the list of programme supervisors.

The second category of changes involves offering a new elective course for students. Ms. Nino emphasized that the addition of these courses is due to the need to deepen sectoral competence within the educational programme, as well as the implementation of additional measures recommended by the accreditation experts and the EU Erasmus+ Jean Monnet module project.

Ms. Nino explained to the board members that in the Bachelor's programme, students will have the opportunity to choose the following course as an elective: "Introduction to the EU Enlargement Policy and Law- Erasmus+ Jean Monnet Module". Additionally, a new elective course, "The Impact of EU Enlargement Policy and Law on the Democratization of Candidate Countries- Erasmus+ Jean Monnet Module", has been added at the Master's level. She clarified that each change has been coordinated with Mr. Giorgi Makharoblishvili, the head of the Quality Service of the Faculty of Law.

The third category of changes concerns the programme supervisors who passed away during the accreditation period. Since a deceased person cannot serve as the programme supervisor, the issue of replacing lecturers has come up for discussion.

Ms. Nino provided the board members with detailed information about the changes, which are presented in **Annex N8**.

Voting Result:

The decision was made unanimously.

Resolution:

The board members discussed the proposed changes to the Bachelor's and Master's programmes at the
Institute for European Studies of the Faculty of Law. The changes presented in Annex N8 highlight the
necessity of implementing these proposed modifications.
